## **CONDITIONS OF HIRE**

Terms: All terms are per week/booking for the property equipped as described unless otherwise stated.

Payment: A deposit of £50 per week is required upon booking. The balance is to be paid one month before your holiday. If the holiday is booked within 30 days the total cost of the holiday is required.

Booking Cancellation: In the event of the hirer wishing to cancel prior to commencement, upon written instructions from the Hirer the Owner will attempt to re-let the property. If re-letting can be arranged a refund may be made at the Owners discretion. We highly recommend taking out travel insurance in case you need to cancel as refunds may not be provided.

Hirers Responsibility: The Hirer is responsible for the property and is expected to take reasonable care leaving it in a clean and tidy condition, bagging all used bed linen and used items such as bath mats, tea towels etc in the provided bags. Any breakages must be reported before departure. In the event that the property is left in an unreasonable condition The Owner reserves the right to charge the client for additional cleaning costs incurred, costs for any damage/breakages and refuse future holidays.

If the Hirer acts in an unreasonable manner which causes a nuisance to others then the Owner has the right to ask the Hirer to leave.

Number of Persons: the maximum number of persons allowed is shown in the description for each property. Additional persons, except babies in cots, cannot be accommodated. No single sex group bookings, stag or hen parties etc permitted.

Animals: No animals are to be brought to the property under any circumstances either by the Hirer or their visitors. With the exception of registered assistance dogs by prior arrangement.

Occupation and Departure: Unless stated otherwise the letting period shall commence at 4pm on the first day of letting and shall terminate at 9.30am on the last day. All bed linen should be stripped from used beds and placed in the linen bags provided.

Hirers Property: No liability is accepted by the owner for loss or damage to the hirers or guests property or to any accident or injury sustained by the hirers, their guests or visitors.

Modifications and Descriptions: Every effort has been made to ensure that the property description is correct. However the right is reserved to make modifications to the property specifications that are considered necessary in the light of operating requirements.

The Owner has the right to inspect the property and carry out necessary repairs.

There are no electric vehicle charging points on site. The charging of electric vehicles is strictly prohibited. A £200 fine may be issued should the hirer charge an electric vehicle from any property.

BBQ's, naked flames or smoking including e-cigarettes is strictly prohibited, including on the verandas. Deep fat fryers are not permitted to be used in any of our properties.
